DECEMBER 5, 1960

The Session held its regular stated meeting Tuesday night, February 8, 1966, at 7:30 P. M. at the church. Rev. Barker, moderator.

Elders present: D. Albright, V. Albright, Anderson, Bates, Brown, Glasser, Hippard, Jones, Lippsey, McElveen, McHatt, North, Smith and Spencer.

Meeting was opened with sentence prayers, after which the minutes were read and approved.

Received a note from Mrs. Barker expressing her appreciation to the Session for her Christmas gift.

Received a communication from the County Zoning Board advising a change in zoning.

Chas. Hor. would not be present at the Session to speak.

A motion to change in Chas. Hor. to do so.

A committee for return and Expect received.

Motion carried.

In setting up the space arrangement the Christian Education did not take into consideration that the Kindergarten had plans to use the space in the future and it was suggested that both committees be authorized to work together and solve the space problem and present to Session on Sunday morning.

Evangelism - Anderson, Chairman. No change.

Anderson stated that committee is formulating plans for the Home Bible Study group for one night a month and to be held on a night that would not be in conflict with another group. They were not planning on using any aids other than the Bible.

A motion by Jones and seconded by D. Albright that Anderson be given the go ahead with the planning of night neighborhood Bible Classes. Motion carried.

A motion by Anderson and seconded by D. Albright that Roy Waddell and Bob Willey be allowed to teach our adult Bible Classes. Motion carried.

Visitation - McElveen, Chairman. No change.

Spencer & Frances E. Green were under consideration.

A motion was carried.

Dates said the committee was formulating plans for the World Mission Conference and were proceeding on asking for pledges from the congregation for World Missions. The amount of money to be used for this purpose was discussed and finally agreed that for April to April would be the best. In as much as Graham could only be here on March 17th., and 18th., it was suggested, that we have a covered dish supper Thursday night at 6:15 P. M. and have Graham as the main speaker. On Friday morning for the Morning of the Lord service and Saturday for the Evening of the Lord service. Friday night service with the emphasis on Youth with Graham and McKay. Then Saturday morning have the Men's breakfast with McKay as the main speaker. There would be a Saturday night service.
